Muskegon Central Dispatch 9-1-1 Operating Millage Renewal
Shall the total constitutional tax rate limitation in the County of Muskegon be renewed the amount of up to .30 cents (\$.30) per one thousand dollars (\$1,000) (.30 mill) against all taxable property in the County of Muskegon for a period of 7 years beginning with December 1, 2023 levy and ending with the December 1, 2029 levy so as to provide funding for the operations of the 9-1-1 Central Dispatch?
